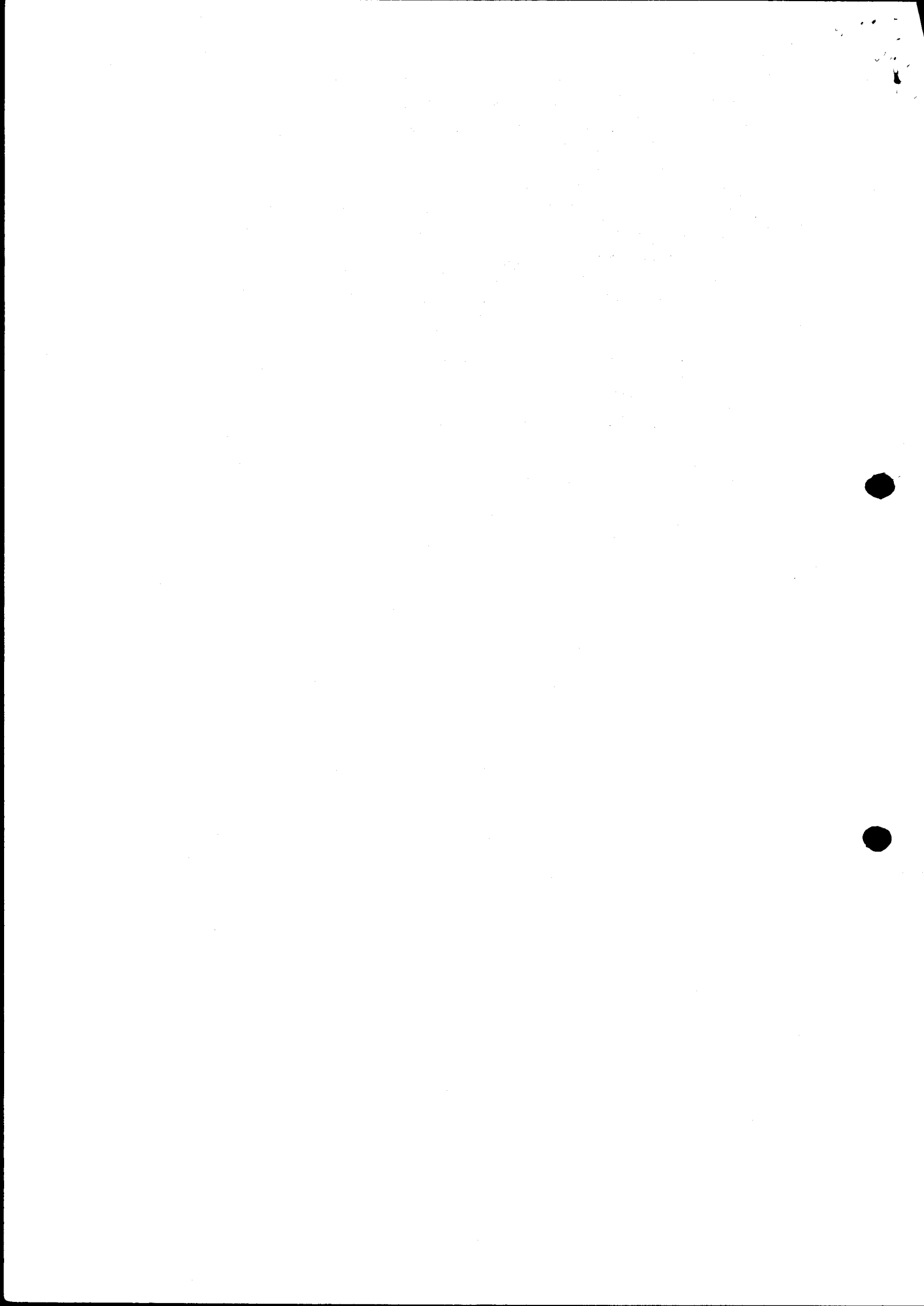

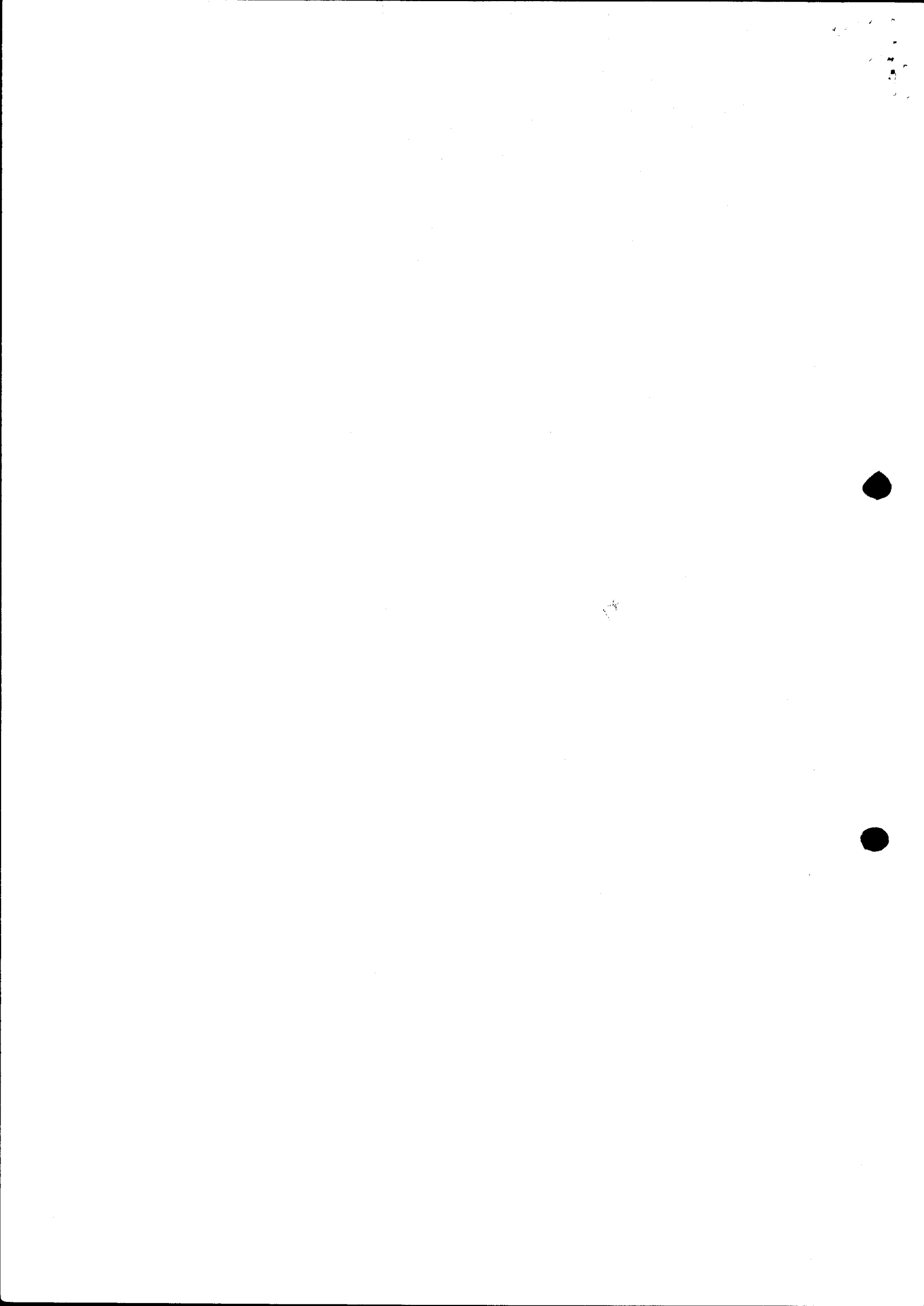


1. That the contract between the Procuring Entity and the Successful Tenderer dated 1<sup>st</sup> September 2006 be and is hereby terminated.
